

INVESTMENT POLICY

The Fund invests in long-term fixed income assets denominated in U.S. dollars that have an overall credit quality suitable for institutional investment. The financial duration of the portfolio is normally between two and fifteen years. Its mission is to accumulate interest on long-term bonds with the capital gains resulting from active trading of its fixed-income securities portfolio. The Fund actively manages the dollar/euro exchange rate risk. 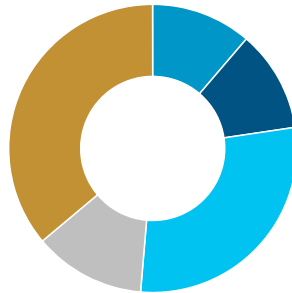

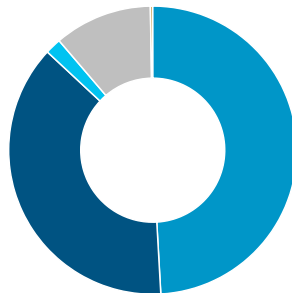
Duration allocation
