INVESTMENT POLICY

The Fund invests evenly in bonds and international equity securities. Its asset allocation is geared towards bonds of issuers both public and private and stocks of companies listed in European and US markets and, in a lesser extent, in Japanese and emerging markets. The Fund's portfolio is normally invested around 50% in stocks, although this allocation is actively managed and placed above or below this level according to the expectations about the stock market, without ever exceeding a maximum of 75% or a minimum of 30% of the asset base, and without establishing any capitalization limit. The selection of securities takes into account not only economic and financial aspects but also extra-financial criteria of sustainable investment, environmental, applying the ESG methodology developed by Amundi. 




