

# Key investor information

This sub-fund is managed by Amundi Luxembourg S.A., an entity of Amundi group.

# Objectives and investment policy

The objective of the sub-fund is to generate long-term capital growth investing in a concentrated portfolio of UCITS, other UCIs and exchange traded funds ("ETFs"), which will in turn invest in fixed income securities issued by government bodies and corporations located all over the world as well as in equity securities issued by corporations located all over the world. The sub-fund will seek to achieve its investment objective through exposures of at least ½ of its net assets to a broadly diversified global fixed income portfolio and seek capital growth over the long run.

The sub-fund is actively managed without reference to a benchmark.

The sub-fund is denominated in USD.


Investors of this sub-fund have the right to redeem their shares. Redemption of operations takes place each business day in Luxembourg (Valuation Day). Redemption requests must be received by European Fund Administration no later than 17.00 (Luxembourg time) on the third business day in Luxembourg previous to the Valuation Day. The attention of investors is drawn to the fact that, in exceptional circumstances, the possibility for investors to seek reimbursement may be limited or suspended.

In principle, income from shares in this sub-fund is re-invested (capitalised).

#### Recommendation

The sub-fund is suitable to investors who wish to invest in a concentrated portfolio of UCITS funds and other UCIs which provides exposure to a broadly diversified fixed income portfolio containing a significant portion of equity securities and to bear the corresponding investment risks in exchange of more attractive expected returns than those generated by US Dollar money market as well as to benefit from the long-term capital growth potential of fixed income securities issued by government bodies and corporations located all over the world and equity securities issued by corporations located all over the world. In addition, the sub-fund is targeted to investors with a basic knowledge and/or experience in this kind of investments and a medium risk tolerance, who can bear losses up to the amount invested, and are willing to hold their investment for a period over 5 years pursuing a capital growth investment objective.

#### What does this synthetic indicator mean?

- The sub-fund SABADELL FUNDS SICAV GLOBAL BALANCED ALLOCATION 40 is classified in category 4 because the value of the share may be subject to moderate variations and consequently the risk of loss and the potential gain may be moderate.
- The risk category has been determined on the basis of historical and simulated data and may not be a reliable indication of the future risk profile. The risk and reward category shown does not necessarily remain unchanged and the categorisation of the sub-fund may shift over time.

#### Which risks are not included in this synthetic indicator?

Market risk: general risk associated to the volatility and to the fluctuations in the price of any type of asset. The price of securities specifically depends on the performance of financial markets, as well as on the economic evolution of the issuers, who, in turn, are affected by the global economy and by specific political and economic circumstances of its territory. In particular, investments are subject to

the following risks: market risk for investment in equity, interest rate risk and currency risk.

- Credit risk: risk that the issuer of a fixed income security fails to reimburse principal and interests on time. The sub-fund may invest mainly in fixed income securities issued by both government bodies and corporations which are rated below investment grade.
- Liquidity risk: risk of investing in securities with small capitalization and / or in markets of reduced size and a low contracting volume lowers the liquidity of such investment, which can negatively affect the conditions under which the sub-fund can buy, sell or modify its positions.
- Counterparty risk: risk that the counterparty of a trade fails to comply with his obligations.
- Operational risk: risk of incorrect functioning of the organization in which the sub-fund operates.
- Risk linked to the use of derivatives: additional risks with respect
  to the spot market, as a result of leverage, which can multiply the effects of losses of value of the portfolios, and for those derivatives that
  are not negotiated in regulated markets, risks like the one consisting in a counterparty failing to comply, for not existing a centralized
  exchange that assures the correct functioning of the operations.


The ongoing charges relate to the annual charges; they were calculated on 31.12.2021. The ongoing charges may vary from year to year.
